What is this product?

Type

The product is a share class of FTGF ClearBridge Tactical Dividend Income Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To seek to generate high levels of income and, as a secondary objective, long-term investment growth.

Investment Policy

The Fund mainly invests in equity and equity-related securities of companies of any market capitalisation. These investments may be from anywhere in the world, including emerging markets, although the Fund invests mostly in US companies.

These investments may include convertible securities and real estate funds. To a lesser extent, the Fund may invest in corporate and government bonds and such investments may be unrated or below investment grade.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

Strategy The investment manager uses macroeconomic and Fundamental analysis to identify securities that appear to have attractive dividends and future earnings prospects.

SFDR category Article 6 (does not promote environmental and/or social characteristics or have a sustainable investment objective under EU regulations).

Base currency US dollar (USD).

Benchmark(s) Dow Jones U.S. Select Dividends Index. Used for performance comparison only.

The Fund is actively managed and may deviate materially from that of the benchmark(s).

Under normal market conditions, the Fund targets an average dividend distribution equal to the benchmark + 0.75% (net of fees; not guaranteed).

Share Class Policy

For this share class all, or some portion of, net income is declared and paid monthly to shareholders.

For this share class, the manager intends to apply a NAV hedge "(Hedged)" which intends to minimize fluctuations between the base currency of the fund and the share class currency.

For this share class, in addition to net income being paid to investors as dividends, all or some portion of capital gains, and a portion of capital may be paid to investors as dividends. While this can increase the total dividends, it limits the potential for future capital growth.

Buying and selling shares

You may normally buy or sell shares on any day the New York Stock Exchange is open for business.

Intended retail investor

Investors who understand the risks of the Fund and plan to invest for at least 5 years. The Fund may appeal to investors who:

- are looking for regular income
- are interested in exposure to global equity markets as part of a diversified portfolio
- have a high risk profile and can tolerate significant short-term changes in the share price

Product availability The Fund is available to all investors with at least basic investment knowledge, through a wide range of distribution channels, with or without the need for advice.

Terms to understand

convertible securities: Bonds that offer the option or the obligation of receiving repayment of principal either in cash or shares in the company.

emerging markets: Markets of less economically developed nations, such as some nations in Asia, Africa, Eastern Europe and Latin America.

equities: Securities that represent partial ownership of a company.

What are the risks and what could I get in return?

Risk Indicator

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- SGD 20 000 is invested
