## What is this product?

### Type

The product is a share class of FTGF ClearBridge Global Growth Leaders Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

### Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

### Objectives

#### Investment Objective

To seek long-term investment growth through growth of capital.

#### Investment Policy

The Fund mainly invests in equities of companies in any industry and of any market capitalisation. These investments may be from anywhere in the world, including emerging markets.

**Derivatives and techniques** The Fund may use derivatives for reducing risks (hedging) and costs, but not to generate additional income or growth (in accordance with the risk profile of the Fund).

**Strategy** The investment manager uses Fundamental analysis to select companies that appear to be undervalued, based on such factors as expected long-term earnings, the value of business assets and the costs to replicate the business.

**SFDR category** Article 8 (promotes environmental and/or social characteristics under EU regulations).

The investment manager applies a proprietary rating methodology using various ESG criteria to assess long-term opportunities and risks and favours high-performing companies on ESG factors, such as climate risk, workplace safety and corporate governance and determines whether a company is a leader. It also excludes or restricts investments in certain industries that are harmful to the environment or society, such as weapons and tobacco. The investment manager engages in dialogue with companies concerning ESG issues.

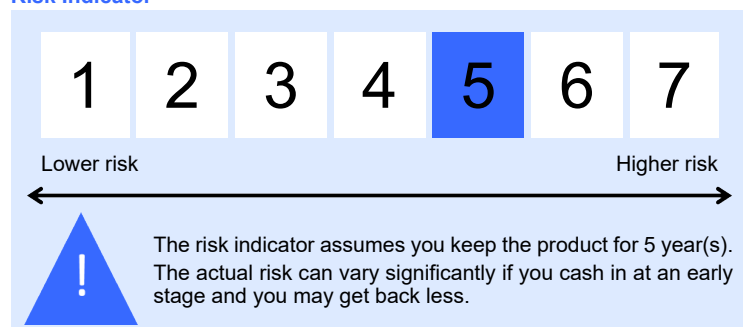

## What are the risks and what could I get in return?

### Risk Indicator

## What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

## What are the costs?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
