## What is this product?

### Type

The product is a share class of the sub-fund Franklin Shariah Technology Fund (the "Fund") which is part of Franklin Templeton Shariah Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

### Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

### Objectives

#### Investment Objective

To seek long-term investment growth, through growth of capital, from a portfolio of Shariah-compliant equity securities.

#### Investment Policy

The Fund mainly invests in Shariah-compliant equities of companies of any market capitalisation in technology sectors, such as computers and electronic components, information technology, internet, telecommunications, and media and information services. These investments may be from anywhere in the world, including Mainland China.

These investments may include depositary receipts. To a lesser extent, the Fund may invest in corporate bonds.

**Strategy** The investment manager uses Fundamental analysis of companies and considerations of global technology trends to select companies that appear to have high quality management, a strong market positioning and high or rising profitability.

**SFDR category** Article 6 (does not promote environmental and/or social characteristics or have a sustainable investment objective under EU regulations).

**Base currency** US dollar (USD).

**Benchmark(s)** S&P Global 1200 Shariah Information Technology Index. Used for performance comparison only.

The Fund is actively managed and may deviate materially from that of the benchmark(s).

### Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

### Buying and selling shares

You may normally buy or sell shares on any day the New York Stock Exchange is open for business.

### Intended retail Investor

Investors who understand the risks of the Fund and plan to invest for at least 5 years. The Fund may appeal to investors who:

- are looking for long-term investment growth
- are interested in exposure to Shariah-compliant equity markets as part of a diversified portfolio
- have a high risk profile and can tolerate significant short-term changes in the share price

**Product availability** The Fund is available to all investors with at least basic investment knowledge, through a wide range of distribution channels, with or without the need for advice.

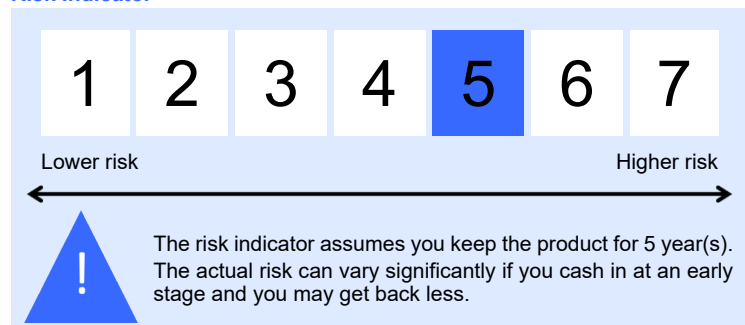

## What are the risks and what could I get in return?

### Risk Indicator

## What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets of the Fund are held separately from FTIS by the depositary. J.P. Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- SGD 20 000 is invested
