## What is this product?

### Type

The product is a share class of FTGF Western Asset Asian Opportunities Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

### Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

### Objectives

#### Investment Objective

To seek to maximise income and growth of capital (total return).

#### Investment Policy

The Fund mainly invests, directly or indirectly through derivatives, in corporate and government debt securities issued by Asian issuers.

These investments may be of any duration, investment and below investment grade (or comparable) and have fixed or floating rates.

The Fund may also invest in convertible securities, including contingent convertible bonds, and asset- and mortgage-backed securities.

**Derivatives and techniques** The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

**SFDR category** Article 6 (does not promote environmental and/or social characteristics or have a sustainable investment objective under EU regulations).

**Base currency** US dollar (USD).

**Benchmark(s)** Markit iBoxx Asian Local Bond Index. Used for performance comparison, risk management and some limited portfolio composition constraints.

The Fund is actively managed and may deviate materially from that of the benchmark(s).

#### Share Class Policy

For this share class all, or some portion of, net income is declared and paid annually to shareholders.

#### Buying and selling shares

You may normally buy or sell shares on any day the New York Stock Exchange and banks in Singapore are open for business.

#### Intended retail investor

Investors who understand the risks of the Fund and plan to invest for at least 5 years. The Fund may appeal to investors who:

- are looking for a combination of income and investment growth
- are interested in exposure to debt securities of Asian issuers as part of a diversified portfolio
- have a medium to high risk profile and can tolerate significant short-term changes in the share price

**Product availability** The Fund is available to all investors with at least basic investment knowledge, through a wide range of distribution channels, with or without the need for advice.

### Terms to understand

**asset- and mortgage- backed securities:** Bonds backed by consumer debt (such as mortgages, credit card and other loan-type debt) and whose income derives from the payments received from the underlying borrowers.

**bonds, below investment grade:** Bonds represent an obligation to repay a debt, along with interest. Below investment grade bonds generally pay higher interest rates but are considered less likely to make all scheduled payments or repay the initial debt.

**convertible securities, contingent convertible bonds:** Bonds that convert into shares of a company upon a pre-determined event occurring. Contingent convertible bonds generally pay higher interest payments compared to other bonds due to the higher risk.

**derivatives:** Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

**emerging markets:** Markets of less economically developed nations, such as some nations in Asia, Africa, Eastern Europe and Latin America.

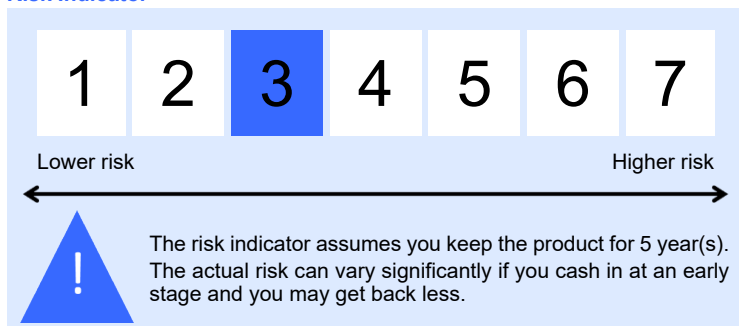

## What are the risks and what could I get in return?

### Risk Indicator

## What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depository. BNY Mellon SA/NV Dublin Branch, as the appointed depository of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depository or its delegates).

## What are the costs?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- EUR 10 000 is invested
