## What is this product?

#### Type

The product is a share class of the sub-fund Franklin ESG-Focused Balanced Fund (the "Fund") which is part of Franklin Templeton Opportunities Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

#### **Term**

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

## Investment Objective

To seek to maximise income and growth of capital (total return).

#### **Investment Policy**

The Fund mainly invests in government and corporate bonds and equities in a balanced proportion. Bond investments are mostly denominated in EUR, and some of them may be below investment grade. Equity investments may be from developed markets anywhere in the world.

To a lesser extent, the Fund may invest in convertible securities, including contingent convertible bonds, asset- and mortgage-backed securities and securities issued by companies that are restructuring or going through bankruptcy.

**Derivatives and techniques** The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

**SFDR** category Article 8 (promotes environmental and/or social characteristics under EU regulations).

The investment manager applies a proprietary rating methodology using various ESG criteria to assess long-term opportunities and risks. The fund favours companies with a high profile and excludes or restricts investments in certain industries that are harmful to the environment or society, such as thermal coal, weapons and tobacco.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.


**convertible securities**: Bonds that offer the option or the obligation of receiving repayment of principal either in cash or shares in the company.

## What are the risks and what could I get in return?

## What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Morgan SE, Luxembourg branch, as the appointed depositary, is liable to the Fund or its shareholders for losses caused by its negligent or intentional failure to fulfill its safekeeping or record-keeping obligations (cash could however be lost in case of default of the depositary or its delegates). ## What are the costs?

**Costs over Time**
