What is this product?

Type

The product is a share class of FTGF ClearBridge US Value Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To seek long-term investment growth, mainly through growth of capital, from a portfolio of US equity securities that are thought to be undervalued.

Investment Policy

The Fund mainly invests in equities of US companies of medium and large market capitalisation.

To a lesser extent, the Fund may invest in equity markets outside of the US. The Fund may also invest in corporate, government bonds and short-term securities. Such instruments will primarily be investment grade, however, some may be below investment grade.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth (in accordance with the risk profile of the Fund).

Strategy The investment manager uses Fundamental analysis to select companies that appear to be undervalued, based on such factors as the companies' financial condition, competitive edge and expected long-term earnings, and have potential for appreciation.

SFDR category Article 8 (promotes environmental and/or social characteristics under EU regulations).

The investment manager applies a proprietary rating methodology using various ESG criteria to assess long-term opportunities and risks. The Fund will mainly invest in higher rated issuers and excludes or restricts investments in certain industries that are harmful to the environment or society, such as weapons and tobacco. The investment manager engages in dialogue with companies concerning ESG issues.

What are the risks and what could I get in return?

Risk Indicator

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depository. BNY Mellon SA/NV Dublin Branch, as the appointed depository of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depository or its delegates).

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- USD 10 000 is invested
