Objectives and Investment Policy

Franklin Biotechnology Discovery Fund (the “Fund”) aims to increase the value of its investments over the medium to long term.

The Fund invests mainly in:

- equity securities issued by biotechnology companies of any size located in the U.S. and other countries

The Fund can invest to a lesser extent in:

- higher-quality debt securities issued by corporate issuers

A biotechnology company is one that earns at least 50% of its profits from, or is devoted to, activities such as research, development, manufacture, and distribution of various biotechnological or biomedical products, services and processes. The Fund will usually invest more in the U.S. than in any other

country.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

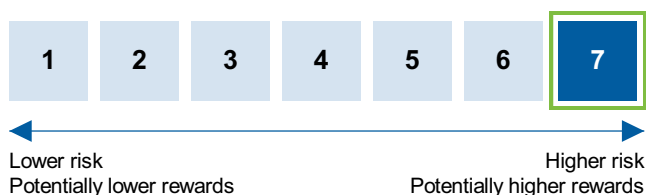

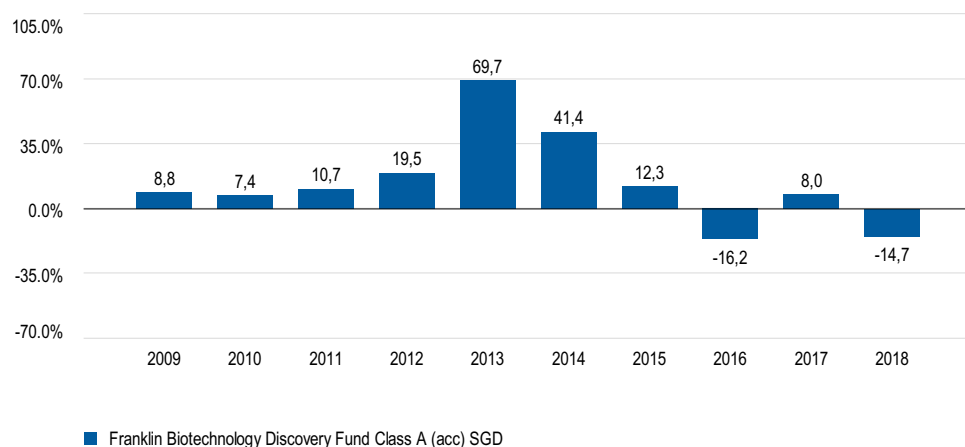
