Objectives and Investment Policy

Franklin European Growth Fund (the “Fund”) aims to increase the value of its investments over the medium to long term.

The Fund invests mainly in:

- equity and equity-related securities issued by companies of any size located in, or doing significant business in, European countries

The investment team focuses on high-quality, financially strong companies that are attractively valued that it believes have the potential for sustainable growth and will provide the best opportunities for increased value over the long term with the least risk of permanent capital loss. The percentage invested in different industries will change over time, based on which industries seem to be offering the best opportunities.

You may request the sale of your shares on any Luxembourg business day. For the distribution share class shown in this document, dividend income is distributed to shareholders.

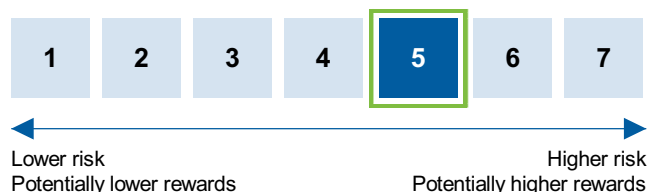

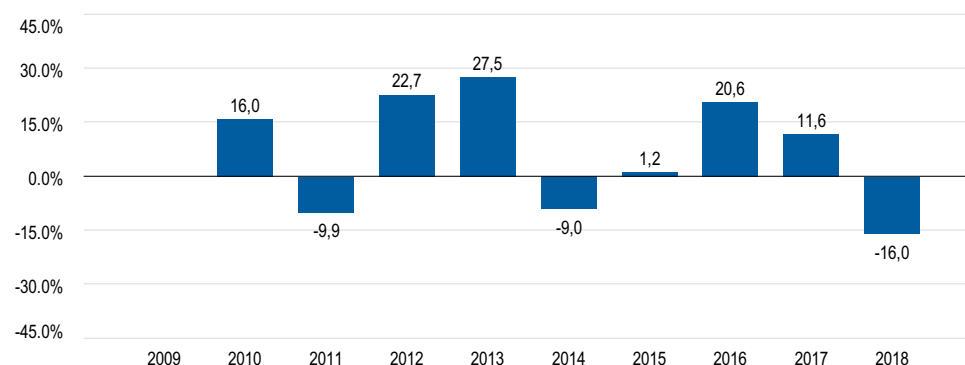
