### Objectives and Investment Policy

Franklin Global Aggregate Bond Fund (the "Fund") aims to maximise the investment return by achieving an increase in the value of its investments and earning income over the medium to long term.

The Fund invests mainly in:

- higher-quality debt securities issued by governments, government-related entities and corporations located in any country

The Fund can invest to a lesser extent in:

- lower-quality debt securities (limited to 10% of assets)
- emerging-market debt securities
- mortgage- and asset-backed securities
- Mainland China through the Bond Connect or directly (limited to 10% of assets)

The Fund can use derivatives for hedging, efficient portfolio management and/or investment purposes (limited to 40% of assets).

The Fund aims to maximise investment return over the medium to long term through a combination of income, capital appreciation and currency gains while approximating the benchmark (Bloomberg Barclays Global Aggregate Index) risk. The Fund invests in a large number of small, low-correlated investments to reduce the risk from any single investment.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

#### Terms to Understand

**Asset-backed securities:** Debt securities whose value and income payments are derived from a pool of underlying assets.

**Derivatives:** Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

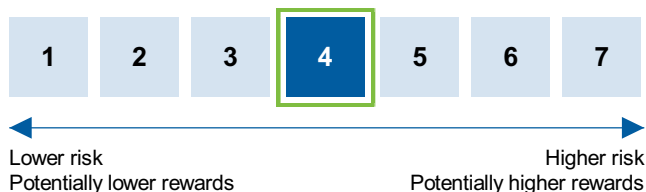
**Hedging:** A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

**Mortgage-backed securities:** Securities whose value and income payments are derived from the ownership of a pool of underlying mortgage debts.

**Debt securities:** Securities representing the issuer's obligation to repay a loan at a specified date and to pay interest.

**Emerging markets:** Countries whose economy, stock market, political situation and regulatory framework are not fully developed.

#### Why is the Fund in this specific category?

The Fund invests mainly in debt securities issued by any government or corporation worldwide. Such securities have historically been subject to price movements, generally due to interest rates or movements in the bond market.

As a result, the performance of the Fund can fluctuate over time.

#### Risks materially relevant not adequately captured by the indicator:

**Credit risk:** the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, non-investment-grade securities.

**Currency risk:** the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

**Derivatives risk:** the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

**Liquidity risk:** the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

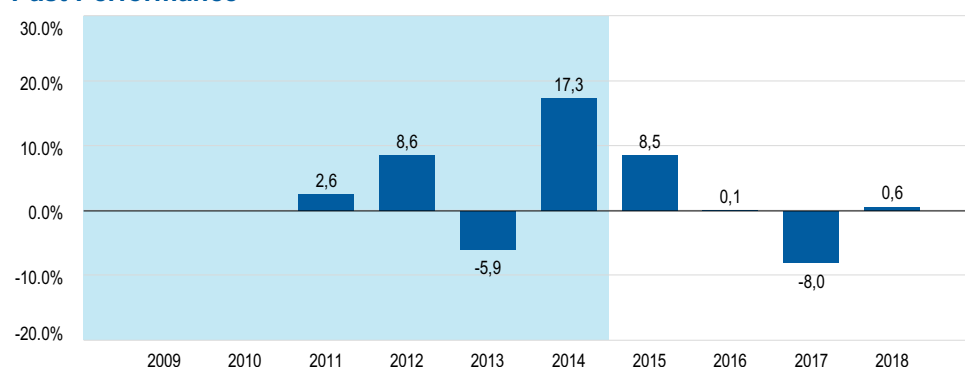
