Objectives and Investment Policy

Franklin Euro Government Bond Fund (the “Fund”) aims to maximise the investment return by achieving an increase in the value of its investments and earning income over the medium to long term.

The Fund invests mainly in:

- higher-quality debt securities issued by governments and government-related entities located within the European Monetary Union (Eurozone countries)

The Fund can invest to a lesser extent in:

- debt securities of any quality issued by governments and government-related entities located outside the European Monetary Union (limited to 15% of assets invested outside the European Monetary Union and lower-quality securities combined)
- derivatives for hedging purposes and/or efficient portfolio management

The Fund will seek to remove currency risk by hedging non-euro investments to the euro. In making investment decisions, the investment team thoroughly researches various factors that may affect bond prices.

The Fund may distribute income gross of expenses. Whilst this might allow

more income to be distributed, it may also have the effect of reducing capital. You may request the sale of your shares on any Luxembourg business day.

For the distribution share class shown in this document, dividend income is distributed to shareholders.

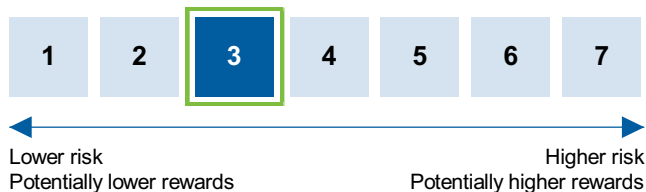
Terms to Understand

Debt securities: Securities representing the issuer’s obligation to repay a loan at a specified date and to pay interest.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Why is the Fund in this specific category?

The Fund invests mainly in higher-quality debt securities issued or guaranteed by governments or government-related entities of countries within the EMU.

Such securities have historically proven to present some stability over time and have benefitted from a limited exposure to interest rates or movements in the bond market in general. As a result, the performance of the Fund can fluctuate moderately over time.

Risks materially relevant not adequately captured by the indicator:

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, non-investment-grade securities.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

Derivatives risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

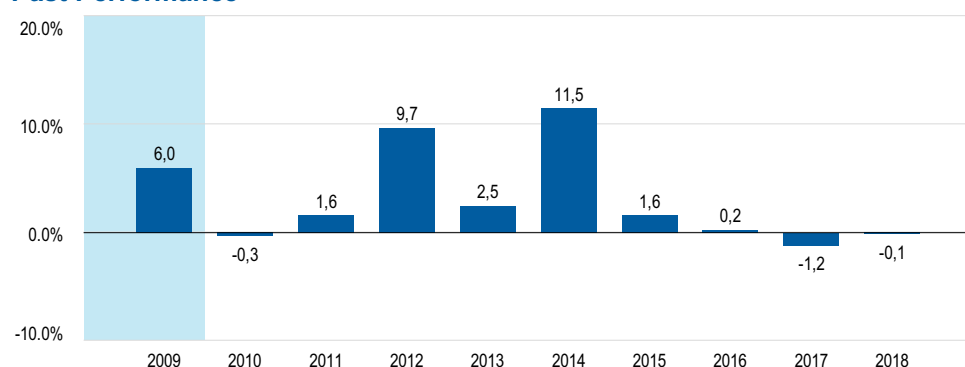
