Objectives and Investment Policy

Franklin Global Listed Infrastructure Fund (the "Fund") aims to maximise the investment return by achieving an increase in the value of its investments and earning income over the medium to long term.

The Fund invests mainly in:

- equity securities issued by infrastructure companies, whose principal business is the ownership, management, construction, operation, utilisation or financing of infrastructure assets, and which are located in any country, including emerging markets

The Fund can invest to a lesser extent in:

- derivatives for hedging and/or efficient portfolio management

The Fund's investment team uses a combination of company and market analysis to select securities that it believes will provide the best opportunities.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the

result of increasing the value of the shares.

Terms to Understand

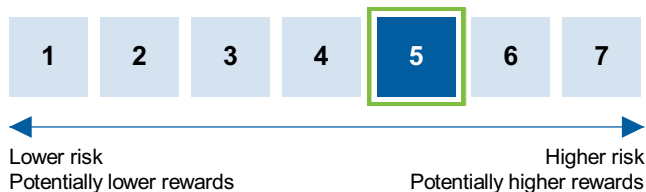
Equity securities: Securities that represent an ownership stake in a company.

Emerging markets: Countries whose economy, stock market, political situation and regulatory framework are not fully developed.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

The Fund invests mainly in equity securities of infrastructure-related

Risks materially relevant not adequately captured by the indicator:

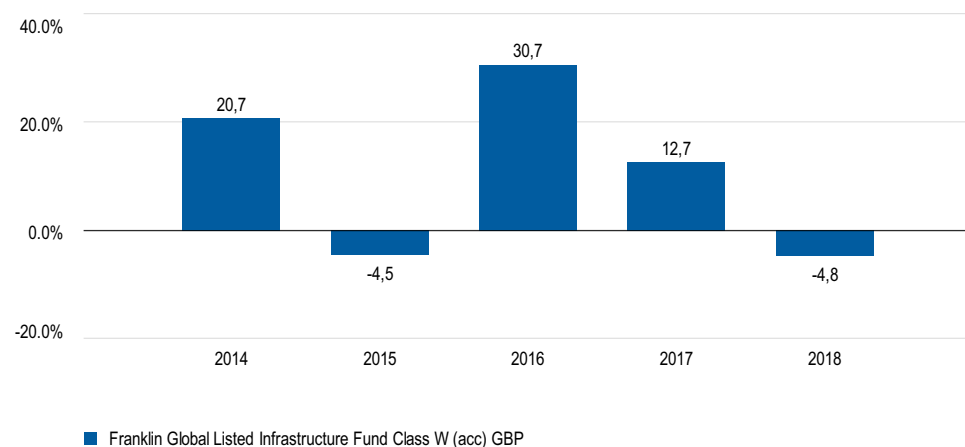
