Objectives and Investment Policy

Franklin European Dividend Fund (the "Fund") aims to earn income and to increase the value of its investments over the long term.

The Fund invests mainly in:

- equity and/or equity-related securities issued by companies of any size located in, or doing significant business in, European countries

The Fund can invest to a lesser extent in:

- equity, equity-linked, or equity-related securities issued by companies of any size located in any country
- derivatives for hedging, efficient portfolio management and/or investment purposes

The investment team uses in-depth financial analysis to select individual securities that it believes provide attractive dividends or the prospect of attractive dividends in the future.

The Fund may distribute income gross of expenses. Whilst this might allow

more income to be distributed, it may also have the effect of reducing capital. You may request the sale of your shares on any Luxembourg business day.

For the distribution share class shown in this document, dividend income is distributed to shareholders.

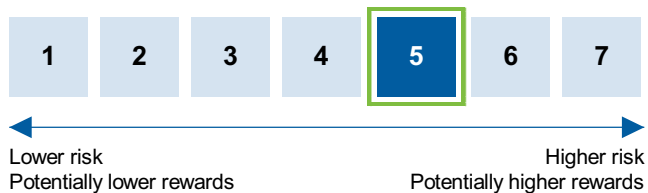
Terms to Understand

Equity securities: Securities that represent an ownership stake in a company.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

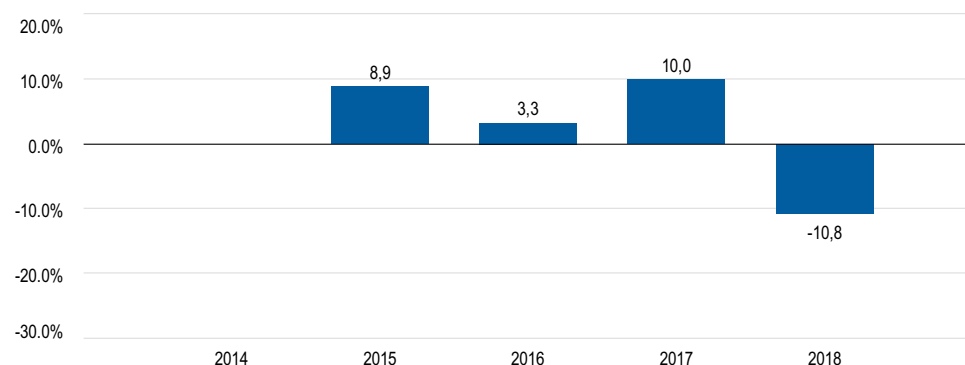
