Objectives and Investment Policy

Franklin Asia Credit Fund (the “Fund”) aims to maximise total investment return by achieving an increase in the value of its investments and earning income over the medium to long term.

The Fund invests mainly in:

- debt securities of any quality (including investment grade, non-investment grade and/or unrated securities) issued or guaranteed by governments, government-related bodies, financial institutions and corporations located in, or doing significant business in, Asian countries which are included in the JP Morgan Asia Credit index benchmark, such as but not limited to Bangladesh, China, Hong Kong, India, Indonesia, Korea, Macau, Malaysia, Mongolia, Pakistan, Philippines, Singapore, Sri Lanka, Taiwan, Thailand and Vietnam

The Fund can invest to a lesser extent in:

- below investment grade securities issued and/or guaranteed by one single government or government-related issuer (limited to 10% of assets)
- securities issued by companies involved in mergers, consolidations, liquidations or other major corporate transactions
- securities in default (limited to 5% of assets)
- units of other mutual funds and exchange-traded notes (limited to 10% of assets)
- derivatives for hedging, efficient portfolio management and/or investment purposes

The Fund may also, to a limited extent, invest in hybrid bonds and contingent capital securities not included in the JP Morgan Asia Credit Index benchmark (limited to 10% of assets).

The investment team believes that individual security selection is the most

important driver of return potential for an Asian credit portfolio. In-depth fundamental credit research is combined with broad economic sector analysis to construct portfolios that have the potential to generate attractive risk-adjusted returns over the long term. Portfolios are built around a diversified set of active management positions that seek to reduce the risk of poor performance from any single position. In addition, tactical or strategic allocations to non-core sectors or currencies allow for further diversification benefits and the potential for additional return opportunities.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital. You may request the sale of your shares on any Luxembourg business day.

For the distribution share class shown in this document, dividend income is distributed to shareholders.

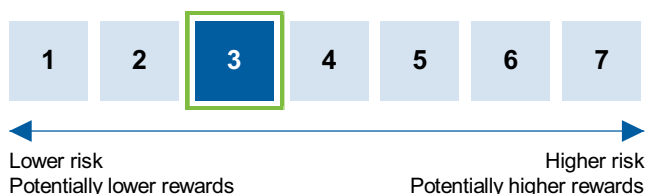

Terms to Understand

Why is the Fund in this specific category?

The Fund invests mainly in fixed or floating rate debt securities of government, government-related, or corporate entities located in Asia, including securities that are rated less than investment grade. Such securities have historically

been subject to price movements, generally due to interest rates or movements in the bond market in general. As a result, the performance of the Fund can fluctuate moderately over time.

Risks materially relevant not adequately captured by the indicator:

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, non-investment-grade securities.

Derivatives risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

Emerging markets risk: the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, and that may be impacted by political/economic instability, lack of liquidity or transparency, or safekeeping issues.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

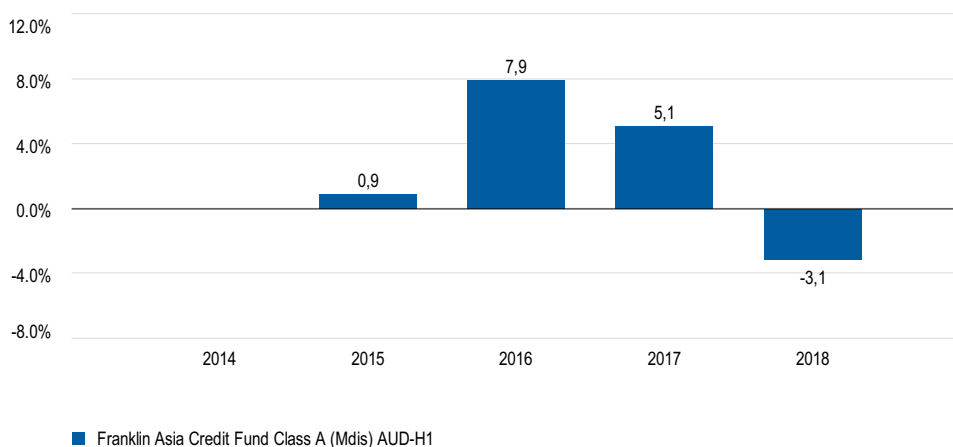
