Objectives and Investment Policy

Franklin European Income Fund (the “Fund”) aims to earn income and, secondarily, to increase the value of its investments over the medium to long term.

The Fund invests mainly in:

- equity and equity-related securities as well as debt securities, issued by governments, government-related entities and corporations located in, or doing significant business in, European countries, including emerging market countries in Europe

The Fund will have a minimum allocation to both debt and equities securities of 35% and a maximum of 65% of its assets.

The Fund can also invest in:

- derivatives for hedging, efficient portfolio management and/or investment purposes
- units of other mutual funds (limited to 10% of assets)

The Fund may also, to a limited extent, invest up to 15% of assets in subordinated debt, which may include hybrid bonds and contingent capital securities, and up to 10% in hybrid bonds and contingent capital securities.

The investment team will tactically allocate the Fund’s assets between equity and fixed income securities across European countries. They will utilise the experience and expertise of the individual Franklin European equity and fixed

income teams to invest in the best opportunities across Europe.

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

You may request the sale of your shares on any Luxembourg business day.

For the distribution share class shown in this document, dividend income is distributed to shareholders.

Terms to Understand

Equity securities: Securities that represent an ownership stake in a company.

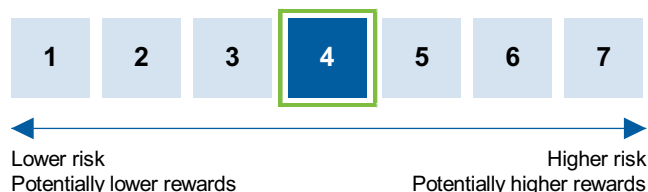
Debt securities: Securities representing the issuer’s obligation to repay a loan at a specified date and to pay interest.

Emerging markets: Countries whose economy, stock market, political situation and regulatory framework are not fully developed.

Derivatives: Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

Why is the Fund in this specific category?

The Fund invests mainly in a diversified portfolio of European equity,

equity-related and debt securities. Such securities have historically been subject to price movements that may occur suddenly due to equity market- and bond market-specific factors. As a result, the performance of the Fund can fluctuate over time.

Risks materially relevant not adequately captured by the indicator:

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, non-investment-grade securities.

Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Derivatives risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

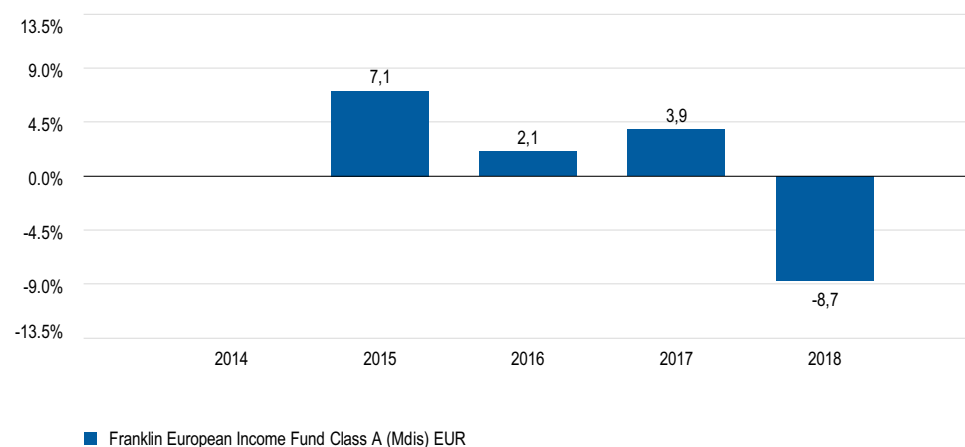
