Objectives and Investment Policy

Franklin Flexible Alpha Bond Fund (the "Fund") aims to earn income and to increase the value of its investments over the medium to long term in excess of the London Interbank Offered Rate (LIBOR) 90 Day (USD) over a full market cycle (being a period of time that spans a full business and economic cycle, which may include periods of rising and declining interest rates).

The Fund can invest up to 80% of its assets (on a net basis) directly or indirectly (through derivatives) in a wide range of debt securities of any maturity, duration or quality (including investment grade, low-rated, unrated securities and/or up to 10% of the Fund's net assets in securities in default) issued by governments, government-related entities and corporations located in any country. The Fund's portfolio may include high yield ("junk") bonds, distressed debt securities (securities of companies that are, or are about to be, involved in reorganisations, financial restructurings, or bankruptcy), convertible securities or contingent convertible securities (investments in contingent convertible securities will not exceed 5% of the Fund's net assets), mortgage and other asset-backed securities as well as credit-linked securities that derive their value from an index. The Fund can also invest in units of other mutual funds (limited to 10% of assets).

The Fund also intends to regularly invest in currencies and currency related

financial derivative instruments as a hedging technique or to implement a currency investment strategy.

The Fund can use derivatives for hedging, efficient portfolio management and/or investment purposes.

You may request the sale of your shares on any Luxembourg business day.

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

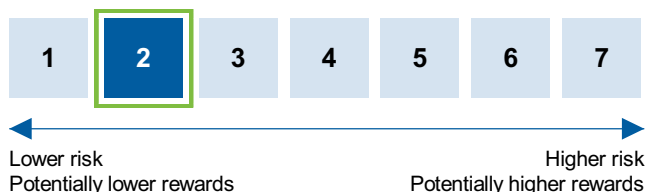

Terms to Understand

Hedging: A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

What does this indicator mean and what are its limits?

Why is the Fund in this specific category?

The Fund seeks to generate attractive risk-adjusted returns over a full market cycle by allocating its investments across a wide range of debt securities and debt obligations of any maturity or credit rating of corporate and/or sovereign issuers worldwide, with the ability to actively use financial derivative instruments. Such securities and investment instruments have historically been subject to price movements due to such factors as sudden changes in interest rates, changes in the financial outlook or perceived credit worthiness of securities issuers, or fluctuations in currency markets. As a result, the performance of the Fund can fluctuate to a small degree over time.

Risks materially relevant not adequately captured by the indicator:

Counterparty risk: the risk of failure of financial institutions or agents (when

serving as a counterparty to financial contracts) to perform their obligations, whether due to insolvency, bankruptcy or other causes.

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, non-investment-grade securities.

Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Mortgage and Asset-Backed Securities Risk: the risk of loss tied to investment in securities which generate return from underlying groups of assets such as commercial and residential mortgages. Such securities can be subject to prepayment and/or extension risks generally triggered by changes in interest rates.

Derivatives risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

Emerging markets risk: the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, and that may be impacted by political/economic instability, lack of liquidity or transparency, or safekeeping issues.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Reduced liquidity may have a negative impact on the price of the assets.

Operational risk: the risk of losses resulting from errors or failures arising from the people, systems, service providers or processes upon which the Fund depends.

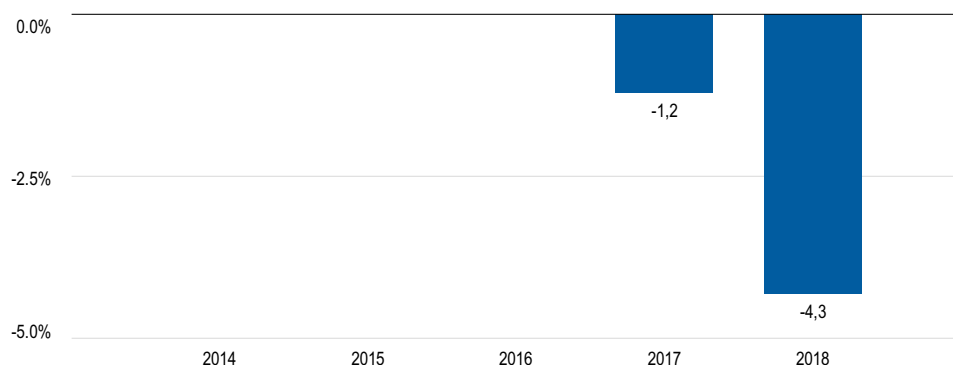
